## **Report Cards and Parent-Teacher Conferences**

Report cards and IPPs for applicable students will be sent home on Tuesday, November 29th. You will receive an email with a link to the report card. Only parents/guardians who are receiving our newsletters via email will receive this email. If you would like to add an email to our system, please email Ms. Tricia at tweissent@hrce.ca. For added security, you must use a password to access the report through the link. The password is your child's birthday in the format of YYYY-MM-DD. <u>The dashes are part of the password.</u> For example, if your child's birthday is November 28, 2011, the password is <u>2011-11-28</u>.

Some email servers have detected these messages as spam, so check your junk mail. If you do not get the email by the evening of the 29th, please email Ms. Thompson at cthompson@hrce.ca and she will help you out. If you are having trouble accessing the report due to password problems, please ensure that you have the dashes between the numbers and then email Ms. Thompson for support.

Paper copies can be printed for any families who want or need them. Please let your child's teacher know by November 25 so we can have them printed for you.

Teachers will send home information about Parent-Teacher interviews. They will be held on December 1st in the afternoon and evening and in-person and virtual options will be available.

### Reminders

- Do not send nut or peanut products to school
- Be cautious when dropping off your children at school to make sure that all students arrive safely.
- Respect "No Parking" and "No Stopping" signs when dropping off and picking up your students.
- Check your child's head regularly for head lice. If your child has a case of lice, they can return to school once they have been treated and there are no live lice. Reach out to the school if you need support with this. Your information will be kept confidential.

## **Inclement Weather and School Cancellations**

In the event of school cancellation due to inclement weather and other exceptional circumstances, the decision to cancel school is made as close to 6 am as possible. Here are some ways you can find out:

At times schools may be cancelled by "Family of Schools". We are in the CP Allen family of schools.

In the event school is cancelled during the school day, the decision is usually made by 11 am. The school will contact all families to confirm procedures to release your children. Please ensure your child knows what to do in case of early closure and ensure that your phone numbers and email addresses are up-to-date so we can contact you. Students are not released until we have made contact with a parent/guardian or designate as you identified on the emergency dismissal form sent home in September.

If school is cancelled during the day, we will dismiss students as per their parent/guardian instruction at 12:10. Parents, guardians and caregivers are requested to wait outside their regular dismissal door at 12:10 for their children. Bus students will be dismissed upon arrival of the buses. All students who need to wait for a later pick-up will be supervised until they are picked up. On days where there is a possibility of early dismissal, please ensure you are answering your phone/monitoring your email so we can contact you or the people you designated on the early dismissal form filled out in September. If you have changes to contact information or designated people, please reach out to Ms. Tricia in the office.

On days when conditions exist that it is not safe to open schools at the regularly scheduled time but it is predicted that conditions will improve, a 2-hour delayed opening may be considered. In this situation, students cannot arrive before 10:50 am and classes will begin at 11:10 am. Lunch and dismissal times will not be affected.

#### **Public Consultation**

As part of the recommendation from the Nova Scotia Home for Colored Children Restorative Inquiry, the Government of Nova Scotia is creating an independent Child and Youth Commission. The Child and Youth Commission will help promote and protect the rights and well-being of children and youth in Nova Scotia. The commission will review programs and services for children and youth, including service provided by the Department of Community Services, Department of Education and Early Childhood Development, Department of Justice and Department of Health and Wellness. Public input is being gathered through Public Engagement Sessions and an on-line survey. As the voices of students, families, and educators is vital to this work we are sharing this information with our school community.
